WITNESSETH: that the said Lessor does hereby rent and lease space at the Columbiana County Fairgrounds, 225 Lee Avenue, Lisbon, Ohio, to the said Lessee for the current season, **November 6, 2020 to March 26, 2022.**

Rental for said space is due and payable on the day the storage items are brought to the fairgrounds.

The charge is based on length of vehicle (measured from front of hitch to rear of motor; or overall length of a motor vehicle) according to the following tabulation:

LESSEE AGREES TO:

1. Bring vehicles in between the hours of **8 am and 12 pm (noon) on Saturday, November 6, 2021.**
2. Vehicles will be removed from buildings on **Saturday, March 26, 2022.** Vehicles not removed by this date **will be charged an additional \$5 per day, plus a \$25 charge for each moving.**
3. Use the premises in a careful manner and to reimburse the Lessor for any damage due to his/her occupancy of said space.
4. Be able to provide proof of insurance (if needed) in the form of a letter or certificate, and to release Lessor from any liability for any damage to the property of the Lessee while in building or on the fairgrounds.
5. Surrender the use of the space temporarily at such times as the Lessor may have need of said space.
6. During said season, work is not permitted on vehicles.
7. **All batteries and propane fuel tanks must be removed at time of storage.**

HOLD HARMLESS CLAUSE

“To the fullest extent permitted by law, I agree to defend, pay in behalf of, and hold harmless the Columbiana County Agricultural Society against any and all claims, demands, suits, losses, including all costs connected therewith, for any damage which may be asserted, claimed or recovered against or from the Columbiana County Agricultural Society, its elected and appointed officials, employees, volunteers or all others working on behalf of the Columbiana County Agricultural Society, by reason of personal injury, including bodily injury and death; and/or property damage, including loss of use thereof, which arises out of the alleged negligence of Columbiana County Agricultural Society and/or in any way connected or associated with this contract.”
